

CRITERIA FOR CONTRACT OMNIBUS OPERATOR

1. The activities of the Public Omnibus shall be limited to :
 - a) Staff transportation
 - b) Contract services such as funerals, picnics, school trips and other similar services
 - c) Contract services exclude transfer or Tour Guiding of tourists or transportation of tourist on vacation
 - d) You may transport foreign visitors such as participants to conferences, consultants on working visits, seminars, cultural events, athletes representing their country at sports events, as long as groups are 9 or more in number, and they are not on vacation in the country.
2. The activity is reserved for Seychellois.
3. Directors/Shareholders of car hire businesses will not be eligible to operate/own an omnibus business.
4. Licensed tour operators, tourist guides and taxi operators will not be eligible to operate/own an omnibus business.
5. An omnibus licensee shall be limited to operate a maximum of 10 omnibuses which can be new or second-hand.
6. Imported buses must be new.
7. Approval in writing must be requested to the Road Transport Commissioner for Second-hand buses bought locally and tested by the Vehicle Testing Station no matter the age limit.
8. Buses must carry a minimum of 10 seated passengers.
9. Driver of bus must have class 6 driving licence and must be of the age of 24 years old.
10. Business licence fee SR1000 per vehicle, per year.

Documents to be accompany application

- a) To provide Police Character Certificate with application forms provided by SLA
- b) If Government employee to provide approval in writing from employer to engage in the business activity
- c) Provide proof of home address.

Please do not include the following words in the business name / company:

- a) Tours
- b) Travel
- c) Transfer
